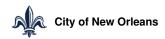
### As of \*December 9, 2019

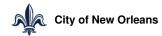

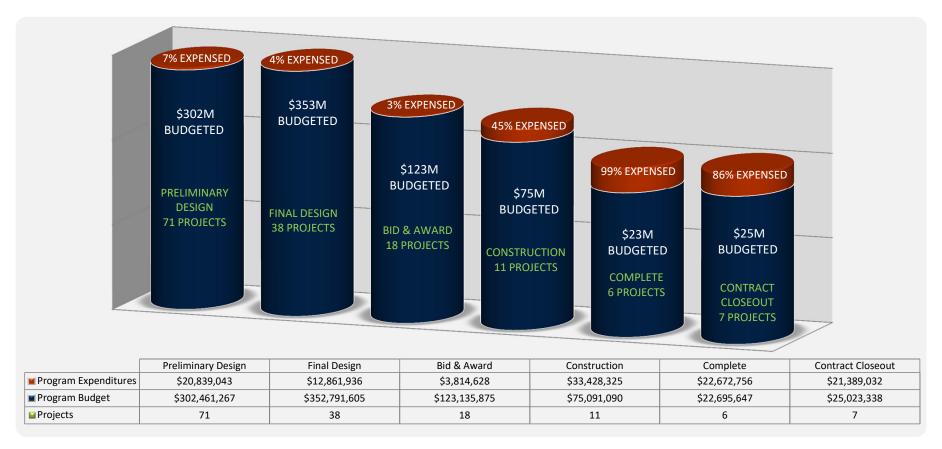
